

LEGISLATION

This month's column is brief, but only because any discussion of pending legislation or the budget would seem to be an exercise in futility. There is now a deadlock between the Tea Party Republicans in Congress and the President over what shape a proposed 2013 budget will take.

As of today, December 26th, the President and Congressional Republicans are at a complete deadlock over the 2013 budget negotiations. No one is sure what will happen in the time up to January 1st, 2013. We do know something will happen, and we as a nation will have to deal with it as we have with all our past protracted political solutions to national problems. However, if in this case there is no agreed upon solution by December 31st, proceeding down the fiscal slope remains as the only political option for the nation to take. If that path is taken, it would essentially restore the Bush tax cuts and makes serious cuts to the Department of Defense budget. There would be no entitlement cuts.

If we go down the fiscal slope, the principal impact for federal employees is that there would be no further immediate attacks on current or retired federal employee wages and benefits.

Additional impacts would be that the 2013 budget would start to reduce the national debt, and the ideologues of both parties will have to retreat and fight another day. Finally, there is the not-so-small issue of a return to an economic recession caused by budget inaction.

While this all sounds like a prescription for a raft of unknown outcomes it is, in reality, how most of us, and it appears now the Congress as well, deal with our serious problems - we do nothing, and then we allow the pieces to fall into place. A disturbing remedy perhaps,

but sometimes the events become too large or complex to resolve, even in a democracy. And, in this case, too politically sensitive to resolve. To get the final results of the current budget debate, continue to watch your local and national news broadcasts; or consult your Ouija Board if you are looking for an immediate answer to the crisis. In the meantime, let's hope the impasse is favorably resolved, if not for the sake of the political parties, then for the nation.

I would recommend that all Chapter members continue to watch NARFE-supported legislation in the legislative tracker in the NARFE magazine. That section will resume in the February issue once legislation is re-introduced with revised bill numbers for the 113th Congress. NARFE continues to be the one bulwark that federal employees and retirees have against unfair and unbalanced legislation that would penalize us in this and future budget debates.
