### **News Flashes in February**

The Congress suspended the debt ceiling on February 11, 2014 and voted to do so until March, 2015. This means there will be no fiscal threats against federal workers and no government shutdowns. Also, to the relief of everyone, the President took the implementation of the Chained-CPI out of his 2015 budget proposal as a possible expenditure cut. This was due to the Republicans in Congress not agreeing to any quid pro quo revenue increases in the budget for the same 2015 budget period.

### **NARFE Legislative Luncheon Convention Preparations**

Speakers at the Legislative Luncheon will be: Mike Teefey-WSFC National Legislative Chair and Don Binder-WSFC NARFE-PAC. Federal legislators and staff, and Kitsap local city and county politicians are being invited to attend. NARFE National President Joseph Beaudoin will also attend the convention and, hopefully, the luncheon.

I will be scheduling meetings with Congressman Kilmer or his staff for his March or April congressional recess. The dates are March 17-21 and April 14-25. Our last meeting was in September, 2013. Congressman Kilmer and all local NARFE chapter presidents were present at that meeting. We hope to use the coming meeting to help him

and his staff understand issues of importance to NARFE members.

### **Current Issues Before the Congress**

The Republican majority in the House of Representatives, for the remainder of the 2014 legislative session and certainly for the period prior to the 2014 mid-term primaries and elections, is not going to take up any significant or controversial issues such as the minimum wage, immigration, or federal employee pension and benefit cuts. Doing so could expose their, at times contentious, internal party divisions between moderates, conservatives, and the far right of the party and diminish their election and re-election possibilities. The only major NARFE related issue that remains on their legislative event horizon is a possible proposal by Rep. Darrell Issa of California, Chairman of the House Oversight and Government Reform, who is expected to propose legislation to modify or replace the FEHBP.

On a brighter note, recent pension contribution increases for federal employees may become an issue of contention in 2014 in lobbying by union representatives before Congress. They want to secure the same level of protection for federal pensions that is extended by Congress to protecting military pensions. After Congress voted last week (February 11<sup>th</sup>) to end military pension cuts in December's budget deal, federal employee unions called on lawmakers Wednesday (February 19<sup>th</sup>) to repeal pension cuts for new federal workers. American Federation of Government Employees National President, J. David Cox, said reversing retirement cuts for new federal workers is only fair. "Slashing retirement benefits for military veterans under the guise of fiscal austerity was an error that Congress and the President rightly have corrected. Now it's time to fix another mistake by repealing similar budget cuts targeting newly hired federal employees," Cox said. National Treasury Employees Union President, Colleen Kelley, also called

for an end to the cuts. "NTEU strongly believes the pension contribution increase for federal workers should be overturned. The pension contribution increase diminishes the government's position when competing for the most highly qualified candidates for federal service," she said. "Federal workers have contributed more than \$138 billion to deficit reduction and economic recovery. This is more than any other group in the country has been asked to sacrifice."<sup>1</sup>

We shall see if the unions and their employees enjoy the same political weight as members of the military who were able to convince politicians to restore military pension cuts in the 2014 Federal Budget.

### **Mid-Term Senate Races**

There are questions about the Senate races and whether Republicans can be successful in taking a majority of the open Senate seats in the mid-terms. The Republicans are staying away from tough issues that will show internal party weakness and remind the public of their recent government shutdown antics. At the same time the Democrats are relying on the young and unmarried female vote in the Senate races which helped secure Virginia Governor, Terry McAuliffe's, election in 2013.<sup>2</sup> At the same time Democrats are distancing themselves from the President due to his relative unpopularity and also due to his Affordable Care Act (Obamacare) that at this point has ambiguous acceptance by the public due to a difficult period of implementation.
