

Fellow members of Chapter 181,

For all of you who were able to attend our WSFC Convention, I hope you found it to be a positive experience and that you enjoyed your participation. I wish to thank all of the members from District IV for all your help in making it a very successful convention; especially our two Co-Chairs Bea Bull and Ralph Sanders.

For those who were unable to attend, I'd like to share some of the highlights. National President Joseph Beaudoin and his wife had to cancel due to illness; he was feeling much improved, however, by last Thursday, May 15th, and was expecting to return to work the following Monday. Lanny Ross, our Region IX Vice President, informed us that there are many changes coming to NARFE as we know it. He provided us with up-to-date information on the Future of NARFE, namely that two of the Recommendations have been taken off the table for the time being. These are Recommendation #29: Open membership to all who support the mission of NARFE even though they are not a current or former federal employee or the spouse of one; and Recommendation #31: Open membership to youth, up to age 26, at a reduced rate, e.g., \$10/year. Lanny fielded many difficult questions about the other recommendations and will carry our questions, concerns, and input back to the National office.

The Memorial Service was touching and carried on the tradition from the 2007 WSFC Convention; after a PowerPoint presentation honoring our deceased members and a ceremony of roses, the roses were carried outside, passed along a line of chapter representatives, ending with me. I took the roses out into Dyes Inlet in an outrigger canoe and placed them, one at a time, into the

water after which Echo Taps was played. The weather and tide were perfect to create this memorable service.

The catered banquet and entertainment were enjoyable. Junior High American Sign Language students signed popular songs followed by several students who sang vocal selections. Federation NARFE -PAC Chair, Don Binder, collected many donations and the Alzheimer's raffle was a huge success, collecting \$915.00!

I will be attending the National Convention in August that will be held in Orlando, Florida. If you have any ideas or input regarding the Future of NARFE, please let me know what they are. I will be voting on these issues. It is important for your voice and opinion to be represented. There will be an open forum at our June General Membership meeting to discuss these issues. Please plan to attend. If you can't, please fill out the survey in this newsletter and mail it, or call or email me. Also, the Executive Board will be holding an interim meeting at the Westside Improvement Club to discuss the Future of NARFE and how I should vote at the National convention. Nothing will ever take the place of us as NARFE members being involved in the process of calling and writing our elected representatives. That has been and will always be the case and I encourage you to continue this very basic need we have as NARFE members.
