

Fellow members of Chapter 181,

This is the time of year we all ask, "Where has the time gone?" As your chapter President, I ask myself, "Why is our Chapter 181 getting smaller?" I know many of our members have passed away and my thoughts and prayers go out to the friends and families of those dear members.

Other members fail to renew their membership, sometimes because they simply forget. I would recommend signing up for a "Dues Withholding" membership. There is a form available on the NARFE National website at NARFE.org. Sign in then click on "Dues Withholding" under RESOURCE LIBRARY in the left hand column. On the "Dues Withholding" page you will find two applications you can fill out online, print, and mail; select the correct application for your situation (new member vs. current member). There is also a PDF brochure with attached application that you can use instead. You will send your application to the NARFE National office for processing. If you don't have online access, please call NARFE National Member Records at 800-456-8410 or contact Ralph Sanders (see back page of newsletter) for a copy of the Dues Withholding brochure/ application.

Another very important part of growing NARFE is getting new members. All of us need to be more PRO-NARFE with our family and friends. For Christmas this year, give them a gift membership and make sure they renew it next year. See page 3 for the ongoing recruiter incentive.

At our National Convention this year we talked about the Future of NARFE. There are many changes that need to be made to bring NARFE into the 21st century. It has been said that the price of progress IS change. As your Chapter Executive Board, we are looking at making some changes to streamline how we can become more effective in growing NARFE.

I just read online that our COLA is going to be 1.7% for the year 2015. Also announced is an average 3.8% increase in health care premiums for federal employees and retirees. I hope this motivates you to continue NARFE's work of lobbying our congressional representatives to switch to the CPI-E formula that takes into account the increased medical expenses we incur as we age. And, while you're speaking with your representative, remind them that the Chained CPI would reduce our COLA, putting retirees further and further behind financially.

At our November membership meeting we will be electing two Executive Board members for a two-year term. If you'd like to serve your chapter in this capacity, or know someone you'd like to nominate, please come to the meeting. We will also present proposed changes to the chapter bylaws for the approval of our chapter members. We would appreciate your participation in both of these processes.

May you stay healthy this very special time of year. We have very much to be thankful for. As your chapter President, I am very thankful for our Executive Board and for your support as chapter members.
