I recently received from NARFE Headquarters some information in the *NARFE Recruiting & Retention Journal* that I thought would be timely to share with you.

**Dues: The Driving Force Behind Renewals**

How many times have we heard the lament, "NARFE dues are too high for what you get"? Do your members understand the full benefits of membership? They may need to be reminded every now and then.

Dues drive our mission by allowing us to have topnotch lobbyists at Headquarters who know the ropes on Capitol Hill and which legislators to approach. They give us funds to develop media campaigns and legislative tool-kits. They help finance member benefits services, information sharing and technical support. Dues help fund federation-wide support of chapter needs for training, information support, recruitment drives and more that advance our mission.

Dues fund chapter and federation mission actions such as publishing and distributing newsletters; hosting events with members of, or candidates for, Congress; supporting NARFE members who do mission-based business for office supplies, travel, mission success planning, and/or training and related expenses; recruiting at health fairs, community activities, senior expos, local media and otherwise.

Dues pay for the monthly award-winning NARFE magazine. Remember: If you and your spouse are both members, please continue to receive a magazine in each name. The number of copies sold determines advertising rates. The distribution numbers determine the income NARFE gets from ads and the percentage discount you get from our affinity partners.

Take the extra copy to the library, your doctor's office, the community hall, the local congressional office, or to your neighbors or friends. The magazine is a fantastic public relations and recruitment tool for getting the value, message and brand name of NARFE recognized.

So, counter these dues-related questions with confidence.

- What other organization can you belong to that works to protect your federal annuity and health insurance program?
- Explain how dues are structured. Emphasize the savings NARFE offers with dues withholding where retired members automatically enjoy a 15 percent discount off national dues.
- Compare NARFE costs with other lobbying groups in DC. Many other organizations charge more for far less in return.
- Mention that NARFE magazine is worth more than the cost of membership. In addition, members get online information and updates from National.

## LEGISLATIVE REPORT

This report is all about money, your money. We are very early in the budget process, so we will be seeing changes as we go along during the next several months. The important thing is that we do not lose sight of what is going on during this time.

Representative Westerman R-AR introduced legislation, HR 1230, placing employee retirement on the High-Five rather than the existing High-Three wage system. If passed, this law would take effect January 2017 and save 3.1 billion dollars over ten years. This would be devastating for federal employees who are already paying an increased amount of their wages toward retirement.

The good news is, Representative Davis, R-IL has introduced HR 973. This legislation would repeal the Government Pension Offset (GPO) and Windfall Elimination Provision (WEP) laws. NARFE supports this legislation and we have supported similar legislation in the past.

Both the House and Senate budget committees have completed the mark-up of their 2016 budget proposals. The House proposal would increase retirement contributions with no percentage or implementation or time line mentioned. Also there would be no raise for active employees as mentioned in the President's budget proposal. On the other hand, the Senate proposal contains even less in details. This plan is designed to save 170 billion dollars over ten years at the expense of active and retired federal employees. This would include changes to the Federal Employee Health Benefit Plan (FEHBP). There again, no details. Both the House and Senate have passed their versions of the Budget.

Stay informed and be ready to act when NARFE National requests us to do so.
