- ✓ Thwarted ALL attempts by Congress to cut the earned pay and benefits of federal employees and retirees.
 - The House of Representatives' Fiscal Year 2016 budget resolution contained eight provisions totaling \$318 billion in cuts to the federal community.
 - The Senate failed in its attempt to pay for highway improvements on the back of the federal community.
 - A budget agreement offsetting sequestration for two years did not take from federal employees or retirees.

- ✓ Successfully prevented a disproportionate and unfair increase in Medicare premiums.
 - Without a COLA in 2016, millions of Medicare enrollees not held harmless would have had their premiums increased by 52 percent, unless Congress or the administration took action.

- ✓ Supported efforts to protect TSP participants from receiving bad financial advice.
 - NARFE testified before the Department of Labor in favor of a rule to hold financial advisers to a "best interest" standard, instead of the current "suitability" standard, when providing advice regarding rollovers.

- ✓ Worked to protect and inform NARFE members following the data breaches at the Office of Personnel Management (OPM)
 - Following the announcements of two OPM data breaches, NARFE has stayed in constant communication with OPM officials to ensure NARFE members have the information they need to protect their financial wellbeing.

- ✓ Worked to increase identity theft protection provided to individuals impacted by the data breaches at OPM.
 - NARFE supports lifetime identity theft protection, while the services offered after the breaches cover only 18 months and three years.
- ✓ NARFE's media coverage reaches new heights.
 - In 2015, NARFE saw unprecedented coverage in the press, thanks to a combination of being out in front on certain issues, and efforts to draw attention to other concerns that were being overlooked by the media.

As you can see, NARFE's mission is being accomplished. You can use this information in your recruiting and retention efforts. You, who are calling and writing your legislators, keep up the good work, and encourage others to get involved.

LEGISLATIVE UPDATE

Steve Ferguson here. Happy New Year.

2015 was a real legislative battle for us. Here are some of the issues we encountered:

Our Federal Employee Health Benefits were (and are) at risk by congress reducing the government's funding level for our premiums.

Our future Cost of Living Adjustments may be reduced through implementation of Chained-CPI.

Mail service may be reduced to five days per week and sorting centers closed. Sorting centers are important for timely mail processing.

Our Medicare Part B premiums escalating by over 50%. Reducing the Thrift Savings Plan G Fund return rate from about 2.5% to .2% to help pay for the Transportation Bill (at our expense).

The combined results of these attacks on our earned benefits would have been catastrophic. The use of the word "catastrophic" is by no means a hyperbole.

Get ready for the 2016 fight to retain your benefits. I hope you made a New Year's Resolution to contact your senators and congressman to oppose each and every attack on your earned benefits. I earned mine with 42 years of service credit which included working at PSNS from 1976-2013, 1-1/2 years of sick leave and 4 years US Navy.

I intend to fight to retain a viable retirement income.

There are new Affordable Care Act tax forms, 1095-B, and 1095-C that you will need when filing your 2015 income taxes. These forms are explained on page 16 of the January NARFE magazine or go to www.irs.gov and click on "Affordable Care Act" under "Hot Topics" (orange box).

Also in the January NARFE magazine is a very important article about changes to Social Security; "groundbreaking...reform measures" as author Mark A. Keen puts it. The changes can greatly impact how you "coordinate retirement and spousal benefits to maximize Social Security income".
