

TAX-AIDE OFFERS FREE INCOME TAX PREPARATION

The IRS and AARP jointly sponsor a program staffed by volunteers to prepare and electronically file income tax returns at no cost to you, the customer. Our volunteers are trained to handle most changes in the tax law for 2015. If you have questions, stop by one of the sites.

Taxpayers we can serve:

All ages, with income from employment, retirement, unemployment, Self-Employment Business (up to \$25,000 in expenses, no employees, no inventory & no loss) and those needing to claim a wide variety of deductions and credits

Taxpayers we can NOT serve:

Those with Rental Income, Depreciation, Home Office, or Self Employment Business with a loss, expenses exceeding \$25,000, inventory, or employees

Taxpayers MUST bring:

- 1) Photo Identification
- 2) Social Security Cards for ALL persons on the tax return
- 3) All 2015 tax documents, such as statements of income from wages, retirement, Social Security, interest, dividends, brokerage statements, and information on college expenses
- 4) Information on your medical coverage and your 1095A, 1095B or 1095C, if you received one
- 5) A list of all of your deductions plus tax documents showing Mortgage Interest and Property Taxes
- 6) Your checkbook with a check showing your routing and account numbers. This is for direct deposit of your refund or withdrawal of the amount due
- 7) Last year's tax return.

Bring in any information you think we might find helpful and let us sort it out.

Please plan to arrive early. We try not to begin preparation of a new return during the last half hour before closing time, to ensure that returns are completed before volunteers are expected to vacate the space used.
