There are Resolutions to be voted on and every member needs to be informed and their opinions heard. To access it online, log into the National site ([www.narfe.org](http://www.narfe.org)) and click on the blue box that says "Strategic Planning". Scroll down and select "Strategic Plan - Final". This is a 50 page document but, if you have absolutely no other way to access it, we can mail you a copy.

It's a little known fact that federal retirees may downgrade their FEHBP at any time; not just during an open season. So, if you're a federal retiree and decide you want to switch from Self & Family to Self Plus One, or from either of those to Self Only, you may do that at any time during the year.

Remember the F-100? "Be Prepared for Life's Events"? Do you have a copy you've never filled out or is it time to update your copy? This is something to think about at the beginning of each new year. Need a copy? Log into the National website ([www.narfe.org](http://www.narfe.org)) and scroll down to "Resource Library" in the left column; click on

"Be Prepared" and the PDF of the document will open. If you have no way to access this information online, I can get a copy for you.
