Fellow members of Chapter 181,

When I receive information about what is going on in NARFE, I wish to share it with you. The following is from the February 2016 issue of the Recruiting & Retention Journal. It is about Webinars and how helpful they can be to all active and retired federal employees.

**"`Survivor Benefits: Key Decisions for Feds of All Ages'** addresses the key decisions you must make with survivor elections and beneficiary designations both PRE- and POST-retirement.

"We know from experience that survivor benefits are a hot topic. Last year, nearly 1,500 feds requested copies of the January 2015 article published in *narfe* magazine after Federal News Radio's Mike Causey promoted it on air.

"We anticipate a high turnout for this event, especially if we base it on the experience from our first four webinars, which boast a total of 3,427 registrants - 696 who are new and reinstated NARFE members. Members attended for free. Nonmembers paid \$39.95 to register for the webinars, and their registration included a one-year membership in NARFE.

"Over the course of the year, NARFE will host six more webinars on topics of interest to both current and retired feds. Pre-retirement, Social Security claims, TSP withdrawal options and health plans are some of the subjects coming up over the next nine months.

"What does this mean to you? NARFE's Federal Benefits Institute webinars are an in-demand and high-value benefit that will be of interest to prospective members.

"It is no secret that easy-to-understand federal benefit and retirement information not readily accessible. NARFE is filling a much-needed education gap for the federal community. The live events are all archived in the member-only NARFE Federal Benefits Institute for on-demand viewing.

"When you find a prospective member with a pre-retirement question or concern about FEHBP and Medicare or Social Security, you now can say, 'NARFE has webinars that will help you with all of your questions - and you can watch many of them right now if you are a member.'

## LEGISLATIVE UPDATE

Steve Ferguson here.

NARFE would like you to show support for H.R. 711, the ***"Equal Treatment of Public Servants Act of 2015"***.

I plan on mentioning this item until our congressional representative, Derek Kilmer, decides to cosponsor the bill. As of 21 April 2016, the bill was up to seventy-eight cosponsors from the previously reported sixty-four. This bill exhibits bi-partisan support with forty-eight republican and thirty democratic cosponsors. Five more democratic house members have acknowledged support since the last newsletter.

Please call Representative Kilmer's Bremerton office at **(360) 373-9725** concerning this legislation or contact his office via the NARFE website Legislative Action Center as follows: Go to [www.narfe.org](http://www.narfe.org) and click on "LEGISLATION" in the left column; in the center of the page, under "LEGISLATIVE ACTION CENTER" click on the blue "CLICK HERE"; select "CONTACT CONGRESS" along the top banner and scroll down to "Take Action". "Cosponsor H.R. 711" is the first item under this heading. This option is available even if you don't have an online NARFE account; i.e., there is no need to log in to send this letter.

If you reside in a different legislative district, go to [www.congress.gov](http://www.congress.gov) to determine if your legislative representative is a cosponsor of H.R. 711. In the search box, type "H.R. 711" and press enter. Click on "[H.R.711](#)" and, on the following screen, select "Cosponsors" from the tabs. You can alphabetize the resulting list by making that selection in the "Sort by" box on the left.

A little bit of bad news for anyone having chosen to protect themselves with the Federal Long Term Care

Insurance Program. It appears the premium rates are poised to increase by a significant amount on or after fall of this year. NARFE will keep you informed of developments on their website and, no doubt, in the monthly *narfe* magazine.

To continue on with last month's "Membership Recruitment 101" information, let me first thank all of the members who are paying their dues in multiple years or have chosen dues withholding. Either of these options saves you and NARFE time and money. These are the types of memberships and costs:

**New member** - \$40 dues;

**Single and multiyear membership** -

one year \$40 + \$10 chapter dues,

two years \$72 + \$20 chapter dues,

three years \$102 + \$30 chapter dues;

**Dues Withholding Member Retiree (Conversion)** - \$34 + \$10 chapter dues, per year. Dues withholding is the best buy. While the price is the same as a three year membership, it is paid from your annuity in monthly increments with no further action on your part. I personally have used dues withholding for almost twenty years with no problems and no bother. Again I would like to thank every member who pays their dues on time, every time, without exception.
