## LEGISLATIVE UPDATE

Steve Ferguson here.

I am still wincing from the pain of our .3 percent Cost Of Living Adjustment (COLA). Social Security tells us the purpose of the COLA *"is to ensure that the purchasing power of Social Security and Supplemental Security Income (SSI) benefits is not eroded by inflation. It is based on the percentage increase in the Consumer Price Index for Urban Wage Earners and Clerical Workers (CPI-W) from the third quarter of the last year a COLA was determined to the third quarter of the current year."*

The CSRS and FERS handbook states the purpose of our COLA but is not as clear as the one above.

NARFE is advocating the use of the CPI-E index calculated by the Bureau of Labor and Statistics. The "E" stands for elderly. It evaluates expenses experienced by the elderly and historically yields a higher COLA value. I don't know anyone who feels the 2017 COLA addressed real world expense increases.

NARFE has expressed 115<sup>th</sup> Congress legislative priorities on their website. Log in to the NARFE website (NARFE.org), go to "Departments", click on "Legislation", click on "Top Issues" and finally click on "Legislative Program". You will find four pages of excellent and relevant information.

## **MEMBERSHIP**

Last month I stated that "we need to get better organized at the grass roots level, helping us to rise to the challenges federal workers and retirees will encounter this coming year." **President Trump has put a hiring freeze on the federal work force.** The information that I will share with you was taken from a Washington Post news article titled "What does a hiring freeze mean for the federal workforce?"

**Are all federal employees affected?** The memorandum excludes "military personnel" or any position deemed necessary for national security or public safety. Civilian defense department personnel could be included or excluded under this memorandum. Office of Management and Budget (OMB) and Office of Personnel Management (OPM) have been tasked to recommend a long-term plan to reduce the size of federal government's work force through attrition. This order shall expire upon implementation of the OMB plan.

**What have we learned from previous hiring freezes?** In 1982, the Government Accountability Office (GAO) said freezes under Presidents Ronald Reagan and Jimmy Carter were "ineffective in managing federal employment." That report said the previous freezes "disrupted agency operations and, in some cases, increased costs to the government." It is a concern that a freeze on federal employment will cause agencies to hire high-priced contractors to do the work that federal employees can and should be doing.

**Has federal employment grown over the years?** "Since the 1960s, the U. S. population increased by 67 percent, the private sector workforce increased by 136 percent, while the size of the federal workforce rose about 10 percent.

This would not indicate an out-of-control and bloated work force."

We need to contact our congressional delegation and make them aware of the fallacies and misconceptions of this plan. Contact information is on the back page of this newsletter as well as in President Ead's article.
