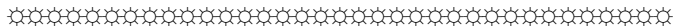

## LEGISLATIVE UPDATE

Steve Ferguson here.

Not much is going on legislatively at this time other than political brinkmanship, so I want to take this opportunity to reiterate NARFE's Legislative Priorities for the 115<sup>th</sup> Congress. Below are the headings; you can find the full details on the NARFE National website without logging in. Go to [www.narfe.org](http://www.narfe.org), click on the "Advocacy" tab along the top and select "Top Issues" from the list on the left. Under the words "Top Issues" choose "Legislative Priorities".

1. Oppose ANY Cuts to the Earned Retirement and Health Benefits of Federal Retirees.
2. Oppose Across-the-Board Federal Employee Compensation Cuts.
3. Support Reform of the Windfall Elimination Provision (WEP) That Would Provide Relief to *Current* Retirees.
4. Oppose Requiring Postal Retirees to Either Purchase Additional Health Insurance Coverage (Through Medicare) or Forfeit Their Earned Retiree Health Benefits.
5. Oppose Unwise Civil Service "Reform" Policies That Would Undermine the Effectiveness of the Federal Workforce.
6. Support Reforms to Calculating Medicare Part B Premiums When There is a Zero or Low COLA to Social Security Benefits.
7. Support Reforms to the Federal Long-Term Care Insurance Program (FLTCIP) That Would Ensure Price Stability And Affordability.

We will continue to be vigilant on the above matters.

## MEMBERSHIP

There was an important fact brought up by our Region IX V.P., Rich Wilson, during his remarks at our last monthly meeting. Why are chapters closing at an ever-increasing rate throughout the country? It is not always because chapters have run out of members. Chapters with a substantial membership are closing because they cannot find members willing to take leadership positions in the chapter. The members who have held these positions for many years have grown old, tired and wish to be replaced. Our chapter is starting to look like that! Many of our

chapter Executive Board members are wearing more than one hat and trying to do their best to cover multiple positions.

I will speak to membership situations, because that is what I am most familiar with. Last year, we gained about twenty-five members and lost 125, which gave us an overall loss of one hundred members for 2017. If we continue losses of this magnitude, we could not stay open for more than another five years. We cannot stop all the losses in our chapter, but with help, we can minimize some of them; but we need assistance with retention and recruitment to do that. Please consider giving a few hours a month to make phone calls or do mailings to reach out to prospective members or those who have dropped their membership. It can be interesting and rewarding work. In the process, you are helping to save our important employee and retiree benefits.

In passing, we are having a problem with some Chapter Life members opting for a National Only membership. If you are a Chapter Life member, you are a member of Chapter 181 for the rest of your life.
