Now that our income tax and health insurance adjustments are complete, I hope everyone appreciates the job done by the Office of Personnel Management (OPM). If not, and you need assistance, be sure to attend our March 12<sup>th</sup> chapter meeting. Our District IV Service Officer, Ralph Angulo, from Sequim, will be our March guest speaker. He is a retired Internal Revenue Service (IRS) lawyer and his NARFE job is to assist us with these types of questions.

As for the economy, the Consumer Price Index (CPI) was up .5 percent in January. This was MORE than expected. The economy is running hotter but retail sales FELL in January. They were down .3 percent while economists expected retail sales to be UP by .2 percent. The Dow Jones Industrial Index (DJI) has been very VOLITILE this past month and these MIXED signals may mean that inflation is rearing its ugly head.

The U.S. House of Representatives bill H.R. 1251 may become very important due to rising inflation concerns. H.R. 1251 requires retirement programs to calculate cost-of-living adjustments (COLAs) using the CPI-E for elderly retirees in lieu of the CPI-W, which is tailored for workers. This is another good reason to come to our March meeting. Steve Ferguson, our Legislative Chair, can explain this.

Speaking of Steve, at February's meeting he did an excellent job of explaining how Congress postponed the high-cost health insurance "Cadillac Tax" for two (2) years during last month's midnight hour congressional budget negotiations. This is a tax on high/standard fee-for-service Federal Employees Health Benefits (FEHB) plans that was to be implemented as part of the "Affordable Care Act".

Hope to see you at our March meeting.

## LEGISLATIVE UPDATE

Steve Ferguson here.

Not much is going on legislatively at this time other than political brinkmanship, so I want to take this opportunity to reiterate NARFE's Legislative Priorities for the 115<sup>th</sup> Congress. Below are the headings; you can find the full details on the NARFE NationI retrieved part of my June 2017 article because it is the same thing, just a different year.

"[President Trump's] budget proposal provides for multifaceted attacks on our retirement benefits and current employee pay and benefits.

"Well...don't hit the panic button yet. It is a long ways from intent to approved budget legislation. I am saying, however, that you should be alert/aware and be considering ways to express your opinion on these matters."

I am concerned with the 2019 fiscal year 1+ trillion dollar deficit budget agreement reached by both political parties. That does not appear to be a sustainable course for government spending. We can expect interest rates to increase and...the inflation rate is increasing.

I checked the Bureau of Labor and Statistics (BLS) CPI-W value for January 2018. I compared it to the 2017, Jul-Sep, CPI-W average, and we are on about a 3 percent inflation rate trajectory for the year. The problem with inflation is that we will always come up short on the next COLA because of the way it is calculated.

H.R. 1251: CPI-E Act of 2017 is our best bet for a meaningful COLA. The BLS has been calculating the CPI-E for decades and it usually provides a larger COLA value than what we receive with the CPI-W.

H.R. 1251 currently has 49 co-sponsors. Derek Kilmer is not one of them. Please call Derek Kilmer's office at

360- 373-9725 and request that he co-sponsor it. While you are at it, contact Wisconsin State Representative, Paul Ryan, the Speaker of the House. His website at [www.speaker.gov](http://www.speaker.gov) invites you to "Speak Out" regardless of what state you live in. His office wants to know what is on our minds. The CPI-E is certainly on my mind.
