## **PRESIDENT**

The results of the NARFE 2018 election were listed in our September magazine. The members voted to suspend the rules and use preferential voting for our new president. The results of this consensus method, and who will be our next president, will be available in early October.

Bremerton Chapter 181 had 498 eligible voting members at the time of the election; twenty-seven (27) members voted, which is a 5.42 percent participation rate. This is lower than our state average of 6.32 percent and national average of 6.77 percent, but higher than the other three (3) District IV chapters. Nationally, about 70 percent of the votes received were by internet with 30 percent by mail.

The economy is presently firing on all cylinders with the Dow Jones Industrial Average and S&P 500 both at all-time highs. Unemployment is at a forty-nine year low, corporate earnings are high, and consumer confidence positive. This foretells a robust holiday season. ## LEGISLATIVE UPDATE

Steve Ferguson here.

Please consider contacting Speaker of the House, Paul Ryan, at [www.speaker.gov/contact](http://www.speaker.gov/contact) and ask that the House endorse a 1.9 percent pay raise for current employees. I did so the day I prepared this article. The website home page has a section labeled "Speak Out" that gives you direct access to express your request. You can reference H.R. 6147, "Interior, Environment, Financial Services and General Government, Agriculture, Rural Development, Food and Drug Administration, and Transportation, Housing and Urban Development Appropriations Act, 2019".

Current federal employees don't deserve to be penalized for continuing to work for the government. The July and August CPI-W average indicates 2.7 percent inflation for the last year which basically means current employees have experienced a 2.7 percent pay cut. I just don't see a rational reason to deny a modest 1.9 percent pay increase.

Here are some other pieces of legislation on which to consider voicing your opinion/position:

- 1) Postal reform legislation (H.R. 756, H.R. 6076 and S. 2629). It would affect 76,000 postal retirees and their survivors by requiring them to acquire and pay for Medicare Part B or lose FEHB Program eligibility. **Congressman Kilmer IS NOT** a cosponsor of this legislation.
- 2) The Social Security Fairness Act of 2017 (H.R. 1205 and S.915). It would affect more than two million Social Security eligible retirees by repealing the Government Pension Offset (GPO) and the Windfall Elimination Provision (WEP). **Congressman Kilmer IS** a cosponsor. He did so six days after introduction last year.

3) The Federal Retirement Fairness Act (H.R. 5389). Employees don't receive retirement service credit for their temporary service time worked since 1 January 1989. They are not allowed to "buy back" that time by paying their share and the government's share that would have otherwise have been paid into the system had they been permanent employees. I remember those years as being unusual in that numerous newer employees were "temporarily employed" for many consecutive years. I know of cases where "temporary" employee status was perpetuated by the shipyard for eight or more years. Imagine eight years of your work history not being considered for your retirement annuity calculation. I am pleased to say that **Congressman Kilmer introduced this legislation** on 22 March 2018. H.R. 5389 is not a give-a-way; it entitles the employee to pay their share and the government's share into their retirement with interest.
