I hope everyone is having a great start to Autumn. There are several initiatives to keep your eye on and do the homework on before voting on November 2. Initiatives 1053, 1098, 1100, 1105 and 1107 could significantly impact our state's ability to meet basic public needs. Please read all that you can. There is great information from the Washington State Budget and Policy Center.

**From the National Convention in Grand Rapids, MI:** An increase to the NARFE National dues was approved by 72% of the delegates. National Dues will be increased to \$40 a year (up from the current \$29 a year). This is **not** the single dues structure that has been presented at the last several conventions with failing results. Our Chapter 888 Dues of \$10 per year will be added to that amount. A three year's structure for National Dues is: 1 year - \$40, 2 years - \$72 and 3 years - \$102. The best deal would be to sign up for **Dues Withholding**, which would be only \$34 per year (a 15% reduction). A small sum would be taken out of your pension check each month. **Remember:** You would still be required to pay your chapter dues of \$10 a year. This dues increase will take effect in 2011 on the **anniversary** of your joining NARFE. ■

## From the Secretary

 Our dedicated 2<sup>nd</sup> Vice President, **Nancy Johnson**, passed away on October 15, 2010. She will be sorely missed by her many friends in Chapter 888.

Region IX Vice President, Lanny Ross, was our speaker for the October Chapter Birthday meeting at the China Sun Buffet. He reported that the 2010 National Convention approved a dues increase for current members as follows: One year National dues - \$40.00; Two years National dues - \$72.00; Three years National dues - \$102.00. Members with National dues withholding will have a 15% reduction to be at \$34.00. The new member fees will start with members whose renewal date is March 2011. Our chapter dues remain at \$10.00 per year.

**Secretary's desk continued**

NOTE: **NEW MEMBERS** receive a **First Year Membership Fee** of \$45.00. Under NARFE bylaws, "one-third (1/3) of the membership fee shall be returned to the chapters in lieu of the first year's chapter dues."

Lanny reported that at the end of August 2010 NARFE's total donations to Alzheimer's research was \$8,813,740.00. 1,001 members in Region IX passed away between the 2008 and 2010 National conventions. Only Lanny and one other member of the NARFE National Board are incumbents; there are 8 new board members. The Bipartisan National Commission on Fiscal Responsibility and Reform's report is due to Congress on December 1, 2010. There have been no 'leaks' on what the report contains but *everything* is on the table and this includes federal retiree benefits. It will be very interesting to see what is in the report; and even more interesting to see what Congress decides to do with it.

And finally, I shall not be your secretary next year. The office of Secretary is open and a complete turnover will be provided to my successor. ■

**LEGISLATIVE**

The election will be held on November 2<sup>nd</sup>. The voter's pamphlet reviews and explains each initiative, including arguments for and against, and an estimate of the effect on state and local revenue for the next five years. Voters are asked whether they want: (1) a state income tax (2) to remove the state from the business of selling liquor (3) to require 2/3 of the state legislators' approval to pass tax increases (4) the recent tax on certain foods removed (5) employers to be allowed to purchase private industrial insurance.

Referendum 52 would allow funding bonds to be issued to increase energy efficiencies in public schools. Should we allow more taxes to improve energy efficiency at the schools?


The pamphlet also covers local candidates for Senator and all Federal and State offices. A history of experiences and education, as well as a statement from each candidate is included, explaining what their plans are and the reason why they believe you should vote for them.

Kitsap County Voter's Pamphlet contains a sample ballot and a statement from each candidate for county offices, District Court Judges and Public Utility Districts. These pamphlets should be studied very carefully before you select the way you wish to cast your votes.


